Golf Cart Law

Before you or someone you know takes a golf cart for a drive, be sure to follow the checklist below:

- The golf cart must be insured, permitted, and registered with SCDMV using the following link, http://scdmvonline.com/Vehicle-Owners/Types-Of-Vehicles/Golf-Cart.
- The golf cart must remain within 4 miles of an address listed on the SCDMV permit.
- The golf cart may be operated on roads with posted speeds of 35 mph or less.
- The golf cart may be operated during daylight hours only.
- The driver must be at least 16 years old with a valid driver's license.

There are restrictions on the use of golf carts in the State of South Carolina. Golf carts must be insured and registered with the SC Dept. of Motor Vehicles and may not be operated:

- On primary highways
- More than 4 miles from your residence
- After dark (½ hr. after sunset until ½ hr. prior to sunrise)
- By an unlicensed driver
- On any sidewalk

Parents or guardians allowing an unlicensed child to operate a golf cart are subject to a fine in excess of \$200.00. Golf carts being operated in violation of state law are also subject to being towed at the owner's expense.

Golf carts are allowed on secondary roads with a posted speed limit of 35mph or less and can cross primary roads. All state traffic laws must be obeyed, and the seating capacity of the golf cart cannot be exceeded.
